The year of my 50th birthday, a friend asked me what I was going to do to commemorate this milestone. I didn't have a clue! He then suggested that I run a marathon. He knew that I had been doing the Peachtree Road Race for many years, but in my mind, 6.2 miles was a far cry from 26.2 miles. He suggested that I come to a meeting for an organization called Team in Training and hear what they had to say. For these passionate people, it wasn't just about running. It was about raising money for the number one killing disease of children-leukemia and its related cancers. Needless to say, I was deeply touched. Six months after attending that meeting, I crossed the finish line in San Diego's Rock 'n Roll Marathon! Because of that overwhelming and amazing adventure, I became involved in Team in Training, eventually becoming a coach of several marathon training teams.

As I think about that experience, I am reminded that Team in Training has much in common with the AWC. Our mission statements are similar. Team in Training is dedicated to finding a cure for cancer and improving the quality of life of patients and their families. While our mission statement is broader, we too seek to make a better world.

### Speaker Spotlight



Tallulah Falls School (TFS) President Larry A. Peevy will be our speaker at February's general meeting. As most of you know, Tallulah Falls School was founded in 1909 by the Georgia Federation of Women's Clubs and by Mrs. Mary Ann Lipscomb, who was serving as the president of the Georgia Federation of Women's Clubs (GFWC).

TFS and the GFWC have deep roots in the history of secondary education in Georgia. On July 12, 1909, TFS opened its doors to 21 mountain children from neighboring Habersham and Rabun Counties and continued to serve as both a public and a private institution of learning for more than sixty years. In 1970, TFS became a privately chartered institution serving students from throughout Georgia, the Southeast, the nation, and abroad.

TFS is largely supported by all GFWC women's clubs in Georgia. Today, it is one of the most prestigious schools in the state. TFS is an independent, coeducational boarding and day school serving over 400 students in grades 6-12. The quality of the academic program and the success of the students are priorities that form the foundation for the school. A dedicated and highly qualified faculty, outstanding facilities, a broad and challenging curriculum, small classes, and eager, motivated students all contribute to the accomplishment of academic goals.

There are many organizations doing the same thing for various causes, but it was the training, the camaraderie, and the fundraising support that I received from Team in Training that kept me going back.

At that first meeting, I learned that I was going to have to raise \$3600, which would support the charity and my expenses to San Diego. Given what seemed like a daunting task, I immediately panicked. I do not like asking people for money. Suddenly, running 26.2 miles seemed easier than raising the money. How wrong I was! I attended some fundraising workshops and decided that my first attempt was going to be to write a letter to family, friends, and neighbors about my cause. Commemorating a milestone birthday was no longer my objective. It had been replaced with finding a cure for cancer and saving lives. I could not believe the outpouring of generosity. Friends shared my message with their friends, and, before I knew it, I was receiving the most beautiful, encouraging notes from perfect strangers with checks to support the cause and help me reach my goal, which I eventually exceeded.

You are probably wondering why I am telling you this. No, I am not suggesting that you join Team in Training (however, I would encourage those so inclined to go for it!). The Atlanta Woman's Club has been a 501c3 nonprofit charitable organization now for two years, but, as our accountant pointed out to us, we have not done any significant fundraising. I know the thought of fundraising probably has some of you feeling uncomfortable. I hope that reading about my experience will alleviate some of your fears. The truth is that people are more willing to give to people they know. Organizations want to support other organizations with worthy goals.

I am working with members and researching fundraising ideas that will be presented to the membership within a few months. We hope to start small and move up to more significant events. Hosting a fundraising event will enhance our organization's image of public consciousness and our concern for the community. We will increase our visibility and have the opportunity to educate others about who we are and what we do. Most importantly, each member will have to contribute in some way—with your time, your

unique talents, or with your financial support. We all have something to contribute!

Hosting a fundraiser is a lot like training for an endurance event. In addition to the physical challenge, there is also a mental challenge. Research has shown that our heart can influence and even override signals from our brain. Our heart produces something called "the balance hormone." Studies have shown that we possess the ability to control our heart and have influence over being in balance. The balance hormone helps us to get away from negative thoughts like frustration and stress in order to focus on more positive feelings like love, compassion, and gratitude, which keep our heartbeat consistent. As we embark upon some new challenges in our organization, let's stay focused on the positive emotions of working for a common cause, the enjoyment of doing it together, and, in the spirit of Valentine's Day, let's do it with our hearts!

Presidents Day is Monday, February 17—Why not visit a national park for FREE?

In observance of this federal holiday, when schools and banks are closed, mail is not delivered,



and sales are everywhere, The National Park Service is giving away visits to national parks. All 401 national parks will offer free admission on Presidents Day weekend, **February 15-17**.

## House Bill 732 seeks to make federal gun law enforcement illegal in Georgia

According to *Creative Loafing's* January 23-29 issue, Georgia Representative Tom Kirby (R-Loganville) has introduced HB732 in an attempt to nullify all future federal firearms restrictions in the state by prohibiting state agencies and gun dealers from enforcing any law "relating to a firearm, firearm accessory, or ammunition that is sold, owned, or manufactured commercially or privately in Georgia."

Specifically, the proposed bill states:

Any federal law, rule, regulation, or order which becomes effective on or after January 1, 2014, which:

- 1) bans or restricts ownership of a firearm, including, but not limited to, a semiautomatic firearm or any magazine of a firearm; or
- 2) requires any firearm, magazine, or other firearm accessory to be registered in any manner shall be unenforceable within this state."

The bill also has several co-sponsors and has been sent to the Judiciary Committee for review.

The General Federation of Women's Clubs supports the enforcement of existing gun laws and urges its member clubs to work with their legislators and firearm authorities on all levels to

implement improved methods of safe gun control (Resolution 015-240 Gun Control).



### Nominating Q&A's

A Note from Our President - We will be electing new officers in March, and our Nominating Committee has been working very hard to make sure that the process is conducted according to our bylaws. As a result, I have received calls from many of you asking some important questions. I thought it would be helpful to share those questions and my answers with all of you.



# When was the Nominating Committee appointed?

The Nominating Committee is not appointed. It is elected by the membership. Once they are elected, they meet and decide upon the Chair of the Committee.

### When did this happen?

At our November meeting, I called upon the Chair of the Nominating Committee to conduct the election of the new Nominating Committee. The membership then elected four (4) members and two (2) alternates. A third (3rd) alternate was also elected. No officers or elected Trustees are allowed to serve on the Committee. The Parliamentary advisor serves on the Committee to make sure the process is being conducted according to the bylaws but does not have a voice or a vote in the process.

How long does the Nominating Committee serve?

Two (2) years

### Who can nominate someone for an office?

Club members are encouraged to submit recommendations for prospective nominees to the Nominating Committee.

# If I nominate someone, is the committee required to put that name on the ballot?

No, it is the job of the committee to first make sure that the candidate is eligible to serve. After determining eligibility, they must then make sure that the nominee has the skills and/or experience to perform the duties of the office. If the



candidate meets the criteria, they must then sign the consent to serve form (Standing Rules Article VI C.3 Process, Section 3)

## What if more than one person is qualified to serve?

If the committee determines that more than one person is qualified to serve for an office, then they will put the names of all qualified candidates on the ballot.

### When will the election be held?

At our March 10th meeting

### How will we know who is running for office?

The names of the candidates and Nominating Committee will be in the February newsletter. Candidate bios will also be in the newsletter, and the slate will be posted at the club ten (10) days prior to the election.

### How will we vote on election day?

By ballot

### Will write-in candidates be allowed?

Yes. After the Nominating Committee Chair reads the report (slate), I will then call for nominations from the floor, office by office. Anyone nominated from the floor must sign the consent to serve form. Blank lines will be available on the ballots for nominations from the floor.

#### Who counts the ballots?

I will appoint four (4) tellers who have no direct involvement in the election. They cannot be members of the Nominating Committee or be relatives of the candidates. The tellers will withdraw from the meeting to count the ballots. They will prepare a report and give it to me and I will announce the names of those receiving the most votes at the March 10th meeting.

### What happens to the ballots?

The report and ballots are available for review by the members after the meeting. The ballots are then held in the office safe for thirty (30) days following the election and then destroyed.

I would encourage all of you to review the bylaws and standing rules if you are unclear on any of these answers. Bylaws and Standing Rules are located in the Membership Directory. Please refer to the articles referenced below.

### When does the new board take office?

The installation of newly elected officers takes place at the May meeting and new officers assume their responsibilities on June 1st.
