#### President's Message continued...

When the BOT meets for its monthly meetings it uses the budget in its oversight of operations. When a budget is approved by the membership, it is approving the use of money for the specific purposes outlined in the new budget. When the Budget Committee meets we are very much aware that it is going to take time and effort to develop and implement this financial plan. In order to create an effective budget we must be realistic about our circumstances. We must be consistent with our mission and yet flexible enough to amend the budget should shortfalls, windfalls or unexpected expenses arise.

One of the most difficult and time consuming parts of creating a budget is reviewing the historical data -what has happened in the past and then making assumptions of what is likely to happen in the upcoming year. Differences in previously budgeted amounts and actual amounts come in to play as well as a realistic view of the impact of the economic conditions on revenue and the demand for our service. We are an event facility and a good portion of our income comes from that. Each year we have to anticipate whether or not our income will increase due to an increase in rentals or whether we will remain the same or worse have fewer rentals. Our beautiful clubhouse is an historical building and requires a great deal of maintenance and upkeep. A healthy reserve and realistic financial expectations are necessary to be sure we have what we need to maintain this landmark.

Once we have determined what it will cost to run our business, maintain our building and plan for the future, we then decide how much money we have remaining to fulfill our mission. Specific amounts are then assigned to our six Community Service Projects and Tallulah Falls School. The Chairs of these committees will have from May 1 until the following March 31 to disburse those funds to various organizations throughout the community, nation and world.

I want to assure all of you that our budgeting process is never rushed. By sharing our budget with our accountant and our attorney we are adding a level of expertise and objectivity to the process. This also serves as a safeguard against conflicts of interest and fraud. Our budget is flexible and has contingency plans for when things do not go as well as expected or better than expected. This is simply good management and stewardship of your money and a major step toward fulfilling our mission. For a copy of the budget, please contact Barbara Ilaw, Treasurer.

### Here's to our health!

The Jan/Feb 2013 issue of *GFWC Clubwoman* magazine included a list of facts on the Affordable Health Care Act,

which largely takes effect in 2014. Acknowledging that the law is "one of the most controversial pieces of legislation ever enacted," it concluded that many people who find the law objectionable are basing their opinions on incorrect or incomplete information. Here are just a few of the Affordable Health Care Act's advantages:

- It will reduce the deficit by \$210 billion by 2012 and even more in its second decade.
- Coverage for pre-existing conditions can no longer be denied.
- Actual healthcare costs must account for more of insurance companies' expenditures.
- Women cannot be discriminated against because of gender. <u>This is the part of the law that will</u> <u>impact virtually all of us</u>. Insurance companies will no longer be able to charge higher premiums to women than they do to men. Well-woman visits will also be covered.

Children are given Social Security numbers immediately after birth. Thieves will use these unblemished numbers to open accounts, apply for loans and lease properties. Further, school forms require personal information. In 2004 over 400,000 children were victims of identity theft. Talk to your children about:

- Keeping their information private and never sharing personal information over the Internet.
- Checking their credit history annually.
- Watching the credit card offers by mail or bills in their name and report any suspicious activity to credit bureaus and businesses immediately.
