PRESIDENT'S MESSAGE

Spring is on the way which is difficult to comprehend with all the rain we have had. Although driving around town and seeing the cherry trees blooming and daffodils shooting up, I know we are ready. To begin March, we have Women's History to celebrate.

March is designated as History Month by Presidential proclamation. This month is set aside to honor women's contribution to history. Women's History began in Santa Rosa, California as a local celebration.

An Education Task Force in Sonoma County (California) planned and executed "Women's History Week" in 1978. The organizers selected the week of March 8th to correspond with International Women's Day. The movement spread across the country. In 1980, women's groups and historians, led by the National Women's History Alliance, successfully lobbied for national recognition. In February 1980, President Jimmy Carter issued the first Presidential proclamation declaring the week of March 8th as National Women's History Week. Presidents continued to recognize the week of March 8th as Women's History Week until 1987 when Congress passed Public Law100-9, designating March as "Women's History Month."

Since 1995, each president has issued the proclamation designating March as Women's History Month. There is a theme each year for National Women's Month selected by the National Women's History Alliance. The theme for 2019 is "Visionary Women: Champions of Peace and Nonviolence." This theme honors "women who have led efforts to end war, violence, and injustice and pioneered the use of nonviolence

Only One More State Is Needed: Let's Make Georgia Great as #38

It's not a new idea, but it's still a good one. It's the Equal Rights Amendment.

It was first introduced in 1923. By 1970, four sitting presidents – Republicans Dwight D. Eisenhower and Richard Nixon, and Democrats John F. Kennedy and Lyndon Johnson – had endorsed the Equal Rights Amendment. [Source: http://theconversation.com/in-2019-womens-rights-are-still-not-explicitly-recognized-in-us-constitution-108150] In 1972, it passed both houses of Congress. Thirty states ratified the amendment quickly, soon followed by five more.

At its 1979 deadline, the ERA remained just three votes shy of the requirement for three-quarters of the states' legislatures (38) to vote in favor. Nevada has now ratified in (in 2017), as has Illinois (in 2018). That means only one more state needs to ratify the Equal Rights Amendment – and GFWC believes Georgia should be the state that captures this honorable place in history.

That's why GFWC Georgia is partnering with Equal Rights Amendment Georgia, Corp., a non-partisan, non-profit 501(c)4 organization, to seek the passage of the Equal Rights Amendment in Georgia. Other partners supporting this amendment include the League of Women Voters of Georgia and the American Association of University Women of Georgia.

According to Georgia's equalmean sequal.org, "On January 14, 2019, State Rep. Billy Mitchell (D -Stone Mountain) introduced HR 16 ratifying the ERA. The bill was read a first time on January 15, 2019 and a second time a day later on January 16, 2019. HR 16 is currently in the House Judiciary Committee. In the Senate, the bill is SR 66, introduced by Sen. Nan Orrock (D), Sen. Renee Unterman (R), and a bipartisan group of others.

NOW is the time to lobby your senators and representatives by email or phone calls to demand they support the ERA. Your can find your legislators' names and contact information at https://openstates.org/ga/legislators/.

Text from The General Federation of Women's Clubs 2018-2019 Resolutions, fully revised and updated June 2018:

WHEREAS, The United States Constitution does not guarantee equality of status for women, except with regard to the right to vote, and will guarantee equality of other rights only when an amendment for the purpose is included therein; and

WHEREAS, Lack of ratification of the Equal Rights Amendment (ERA) continuously jeopardizes women's parity with men in the areas of health care, violence, education and employment; therefore

RESOLVED, That the General Federation of Women's Clubs reaffirms its support and urges the immediate ratification of the Equal Rights Amendment (ERA) which would provide that equality of rights under the law shall not be denied or abridged by the United States or by any state on account of gender.

The Board of Trustees Election will be held at the March 11 general meeting to fill 2 positions on the Board of Trustees for the 2019-21 term (June to June). As you select two Trustees, please take time to consider the Board's important responsibilities as outlined by AWC's by-laws listed below. It is important to elect Trustees with the experience, interest, availability, expertise, and collaboration skills necessary to serve effectively. According to the bylaws, Article VII, BOT members shall serve for a term of two (2) years. Therefore, in even and odd numbered years the Board of Trustees will have positions that will expire and will continually need to be filled. This year because we are in an odd numbered year, two positions will expire and should be filled. Please know that BOT members are eligible to serve again on the Board Trustees should they agree to run again. According to our Standing Rules, Articles VI, Section 1, Subsection C6 "The report of the Committee (the slate) should be prepared by the Nominating Chair and posted at the Club at least ten days prior to the March election date. The slate should also be sent to the newsletter editor for inclusion in the edition that immediately precedes the election. The names of Committee members should be included on the posted slate and in the newsletter." The report from the Nominating Committee is as follows: The Nominating Committee has received the following nominations (listed in alphabetical order) for the two positions on the Atlanta Woman's Club Board of Trustees for the 2019-21 term. Each nominee has signed the Consent-to-Serve form and supplied a bio as included here:

The following segment from the By Laws, outlines in more detail the qualifications and responsibilities of the Members that comprise the Board of Trustees:

ARTICLE VII - BOARD OF TRUSTEES

Section 1 – Composition: The Board of Trustees (BOT) shall consist of four (4) elected trustees, the Club president, first vice president, treasurer and assistant treasurer, past BOT chairs in good standing, and the parliamentarian or parliamentary advisor, who serves but has no right to vote. Two (2) trustees shall be elected on odd numbered years and two (2) trustees shall be elected on even-numbered years. The elected members serve for a term of two (2) years.

Section 2 - Qualifications and Restrictions: A candidate for trustee shall have been a member of the Club for at least two years with regular attendance and active participation. An elected trustee may not serve on the Nominating Committee.

Section 3 – Officers: The BOT shall elect from its members a chair, a co-chair and a secretary. These officers shall serve for a term of two (2) years. The co-chair shall fulfill the duties of chair in her absence or inability to serve and shall automatically succeed to the office of chair in case of a vacancy.

Section 4 – Vacancies: If a vacancy occurs on the BOT, it shall be addressed by the Nominating Committee with an election occurring at the following regular meeting.

Section 5 – Duties: The duties of the BOT shall be to: 1. Supervise and direct property and finances of the Club and its facilities. The Club holds title to the property of The Atlanta Woman's Club, also known as The Wimbish House (clubhouse), at 1150 Peachtree Street NE and 1150-B Peachtree Street NE. 2. Direct all agreements and contracts made on behalf of or in the name of the Club for management, use and upkeep of the facility. 3. Maintain clubhouse property and grounds. All major improvements or major repairs must be approved by the Executive Board. 4.

Negotiate loans subject to approval by the Executive Board and Club members. 5. Develop and maintain job descriptions for persons employed by the BOT. These job descriptions must be kept on file in the clubhouse and should include necessary skills, salary range and duties for each position. 6. Chair and co-chair of BOT serve on the Budget Committee. 7. Chair of BOT signs checks in accordance with Article XII, Section 5.

Section 6 – Meetings: The BOT shall meet prior to each monthly general meeting, second Monday of each month, September through June, except in April. The chair of the BOT may call BOT meetings as needed. Five (5) members shall constitute a quorum. A trustee may be removed from the Board if she is absent from three (3) regularly scheduled Board meetings in one fiscal year.

Section 7 – Electronic Voting: The BOT chair can call for electronic votes when necessary for a timely decision. The subject, the motion and second, and the results of electronic votes are documented at the next general BOT session. Five (5) members shall constitute a quorum.

Section 8 – Staff: The BOT shall employ or contract adequate staff for proper functioning of the Club including upkeep, maintenance and financial services. The facility staff shall work under the supervision of the BOT chair. The financial staff shall work under the supervision of the treasurer and/or assistant treasurer. A professional auditor shall be employed on a retainer basis. Legal advice shall be obtained as needed. Section 9 - Employment No member of the Club or her immediate family shall be permanently employed by the Club. The BOT shall be the final authority for employment matters.
