
#### **Lake Charlotte Nature Preserve**

One of the reasons I love to participate in Community Service Program activities is that I get to learn about and participate in things I may never have done otherwise. Being introduced to Lake Charlotte Nature Preserve on an early, wet and windy Saturday morning on February 17, 2023, from 9-12 PM is a prime example.

According to an article by John Ruch, Saporta Reports, this roughly 216-acre acquisition in Southeast Atlanta was approved by the City of Atlanta in April 2020 as a cornerstone of the South River Forest, a vision of 3,500 acres of interconnected green spaces in DeKalb County. The Conservation Fund a nonprofit championed and helped the city to make the purchase. Stacy Funderburke, Conservation Fund, spokesperson said, "It speaks for itself, once you set foot on the site, it is one of the most spectacular forests in the city of Atlanta." Ironically, the City, acquired the property through a pioneering use of its tree fund, which developers and property owners pay into when they cut down trees. This was the first time the tree recompense fund was used to protect existing trees rather than planting new trees. This property is also nearby the former Atlanta Prison Farm that is planned to be redeveloped into the controversial Public Safety Training Center or "cop city."

In another article by Thomas Wheatley, of Axios, the Nature Preserve opened to the public, after months of clean up, in November 2021. This magnificent woodland matters because it's part of a big vision picture to create a massive forest park long the South River. It is centered on the now drained Lake Charlotte, off I-285 and Moreland Ave, and is one of the largest mature forests that is home to shagbark hickories, white oaks and several towering beech trees. The thick tree canopy, tree stumps, and drained lakebed help sustain the forest ecosystem for deer, frogs, butterflies and other beautiful wild flora and fauna.


The main gate entrance to the preserve and is hiking trails is located on Forrest Park Road, (nearest GPS address is 2830 Forrest Park Rd, SE, Atlanta Ga, 30054). Roughly on quarter of a mile after entering the main entrance and through the woods, you'll notice small stone walls. The walls plus some foundations, clumps of daffodils, and a lone stone chimney are remnants of the old



lodges that stood on the property starting back in the twenties. I mention this specific place because I had the privilege of planting four types of trees (gum, mockernut, hickory and persimmon) in this lovely area along with 15 or so other Trees Atlanta volunteers on Friday, February 17, 2023. I am happy to report that the rain did stop, the ground was soft to dig, and the sun did come out. What a magnificent testament to nature this place is and may the vision that preserved this forest from becoming a landfill or used for other industrial development never die.


